

What is a feather flag?

These elegant flags mimic the shape of a feather. Common vernacular also refers to them as "razor flags". In the world of displays, they are the modest flag choice for driving attention to your messaging, without being obnoxious.

What is the shortest flag I can order?

The 9 ft. feather flag (https://www.banners.com/custom-flags/feather-flags) is one of our medium sizes for this flag type. The shortest available height is 7 feet.

Can my feather flag be double-sided?

Yes, it can be either single or double-sided. Note that due to the dye sublimation printing process, the single-sided option will mirror what has been printed on the one side. If you want your messaging to be readable on both sides of your flag, then choose the double-sided option.



How do I assemble this flag?

Fear not, setting up your flag is fairly easy! Take the separate metal rods in ascending order and insert them from smallest to largest. Be firm but gentle while doing this. Next, take the metal stake and pound it into the ground. Finally, take the flag and put it onto the holding stake. Voilà, you're done!



EXECUTIVE SUMMARY

Per House Bill (HB) 1379, all properties must be connected to a central sewer system or upgraded to an enhanced nutrient-reducing onsite sewage treatment and disposal system (ENR-OSTDS) by July 1, 2030. This is required for all areas within a Basin Management Action Plan. The City of Sebastian currently has 9,574 existing septic systems within our City Limits. In Sebastian, this is to reduce nonpoint source nitrogen pollution into the Indian River Lagoon. City staff has begun an evaluation of the City's possibilities to become compliant with the 2030 deadline. The City is currently coordinating with Indian River County to install public sewer infrastructure within the Community Redevelopment Agency (CRA) so that all properties within the CRA can connect to the sewer system in the near future. The City has already applied for grant funding for resident connection fees as was approved by City Council earlier this year. City Staff is looking for Council direction for the next steps in regards to the City of Sebastian outside of the CRA. In conversations with the County Administrator as well as Indian River County Utilities Division, it is not feasible at this time to convert all residences within the City of Sebastian to the sewer utility without a redesign and/or expansion of the existing wastewater treatment facility. Therefore, the City has determined we have three options to ensure the City's compliance by 2030, knowing that any wastewater treatment facility changes by Indian River County would be beyond the deadline.

RECOMMENDATION

City staff is requesting direction to move forward with one or more of the three proposed remediation options.

Option 1 would call for the conversion of all traditional septic systems to an enhanced nutrient reducing system. The estimated cost is \$220,202,000, considering the conversion of 9,574 existing systems and the current rough estimate of \$23,000 per home. If this is the preferred option, Staff is requesting direction to seek out grant funding to assist residents with conversion costs.

Option 2 would call for conversion to sewer within the existing Indian River County Utilities sewer system. Staff is requesting direction to move forward with Indian River County to coordinate funding, design, and construction of an upgrade to the existing sewer system to allow connection of all sites within the City limits.

Option 3 would require an additional wastewater treatment facility be constructed by the City in addition to the County system to allow conversion of all homes to the new sewer system. If this is the

preferred option, Staff is requesting direction to investigate the City's options with the existing interlocal agreement with Indian River County, which makes them the sole utility provider within City limits. Staff is also requesting direction to move forward with hiring a consultant for a City-wide assessment and study evaluating the different types of sewer collection systems as well as the feasibility, design and location identification of a waste water treatment facility. Initial study and evaluation costs could be up to \$600,000. The study would be able to provide a final construction estimate as well as identify our options for grant assistance.

Frequently Asked Questions (FAQs) House Bill (HB) 1379 Requirements for Enhanced Nutrient-Reducing Systems

Introduction

During the 2023 legislative session, the Florida Legislature passed House Bill (HB) 1379, <u>Laws of Florida</u> <u>Chapter No. 2023-169</u>. This law describes areas where enhanced nutrient-reducing onsite sewage treatment and disposal systems (ENR-OSTDS) are now required instead of conventional septic systems.

This guidance document is intended to help the public answer routine ENR questions. If questions are asked that are not included in this guidance, please refer to the contacts in the last question.

Who does HB 1379 apply to? Will HB 1379 impact me?

People who are required to apply for a new septic system (OSTDS) permit serving a property in specific regions of the state ("impacted areas") will be affected by this legislation.

Specifically, people applying for a **new system construction permit for an OSTDS (aka "septic system")** on a lot of one acre or less and within an "impacted area" will not be allowed to install a conventional septic system (septic tank and drainfield). Instead, they must install a special system referred to as an enhanced nutrient-reducing onsite sewage treatment and disposal system (ENR-OSTDS). This requirement became effective on July 1, 2023.

How do I know whether my property is in an "impacted area"?

To determine if the property is within the "impacted area", see the <u>BMAPs and Alternative Restoration</u> <u>Plans - OSTDS Requirements</u> mapping tool.

How do I know if I need a new system construction permit?

If you need to install a septic system where a system has never been installed before, you will need a new system construction permit. The rule also requires a new system construction permit in other situations. See Memorandum <u>DCEH 19-004</u> for other situations where new system construction standards are required.

What is an ENR-OSTDS?

An ENR-OSTDS is an advanced system that reduces nitrogen better than a conventional septic system. ENR-OSTDS meet an overall 65% nitrogen-reducing standard.

There are three types of ENR-OSTDS: NSF 245 aerobic treatment units; nitrogen-reducing performancebased treatment system (nitrogen-reducing PBTS), and Inground nitrogen-reducing biofilters (INRBs). For more information on these systems, please see <u>Enhanced Nitrogen-Reducing OSTDS to Meet</u> <u>Requirements of HB 1379</u>.

Why is reducing nitrogen important?

Nitrogen is a pollutant that can cause environmental and drinking water concerns. Discharge from onsite sewage treatment and disposal systems is one of many sources of nitrogen into the groundwater of Florida. The installation of enhanced nutrient-reducing systems can lower the impact that OSTDS have on the state's ground and surface waters.

Do additional requirements apply to the Indian River Lagoon area?

Yes. Permits for septic systems serving residential and commercial properties that are located within the Indian River Lagoon Protection Program (the Banana River Lagoon, Central Indian River Lagoon and North Indian River Lagoon) have additional requirements. Starting January 1, 2024, all new systems on all lot sizes installed within these areas must install an ENR OSTDS when sewer is not available. By July 1, 2030, all systems located within the River Lagoon Protection Program must connect to centralized sewer or install an ENR-OSTDS or other wastewater treatment system that meets 65% nitrogen reduction. Please use the <u>BMAPs and Alternative Restoration Plans - OSTDS Requirements</u> mapping tool to find areas impacted by the Indian River Lagoon Protection Program.

Why do I have to do this?

During the 2023 legislative session, the Florida Legislature passed House Bill 1379, Laws of Florida Chapter No. 2023-169, which describes the areas in the state that require enhanced nutrient reducing OSTDS. This comprehensive environmental protection legislation covers a variety of environmental areas and supports the goals of Executive Order 23-06. It also builds on Florida's historic investments and accomplishments over the last four years in advancing the protection of our environmental resources. The Onsite Sewage Program is required to implement the components of the law within the program jurisdiction. Other regulatory components will be managed by agencies with jurisdiction over those other programs.

Can I be exempt from this law? Can a variance be granted?

Once an application has been denied for not meeting the requirements, what are the options? The usual (Chapter 381, section 381.0065(4)(h) F.S.) variance process for septic systems in not available for the ENR-OSTDS requirement. However, a person who is impacted by the ENR-OSTDS treatment requirements may petition for an **administrative hearing** filed under Sections 120.569 and 120.57, F.S., this action will not be final and effective until further order of the Department. Because the administrative hearing process is designed to formulate final agency action, the hearing process may result in a modification of the agency action or even denial of the request for a variance or waiver.

When do I have to comply with the new law by?

Applications for new septic systems on lots one acre or less and in an impacted area must comply with the enhanced nutrient-reducing system requirements unless they were received by the county health department prior to **July 1, 2023** and have been determined complete (except for the site evaluation).


In addition, within the Indian River Lagoon Protection Program, starting **January 1, 2024** new systems applicants must install an ENR OSTDS **on all property sizes**. By **July 1, 2030**, all systems in that area must connect to centralized sewer or install an ENR OSTDS or other wastewater treatment system that meets 65% nitrogen reduction.

Is financial assistance available?

The Department of Environmental Protection (DEP) provides financial assistance to local governments (county, city, utilities) for water quality improvements. DEP recommends that the individual homeowners and businesses contact their local government for specific septic upgrade incentive programs to assist with upgrades to enhanced nitrogen reducing systems or septic to sewer conversions.

To: Sen. Erin Grall, Indian River County Legislative Delegation Re.: Stormwater impacts to the St. Sebastian River

The St. Sebastian River is a major tributary to the Indian River Lagoon, which is suffering many impacts from population increases within its watershed over the last several generations. The obvious recreational opportunities of the Lagoon and the Treasure Coast are a significant attraction for residents and tourists alike, and it is unlikely that increases in these populations will decrease anytime in the foreseeable future.

Millions of dollars are being spent, and increasing amounts are needed, to restore the health of habitats of the Lagoon and surrounding waterbodies that are such an exceptional attraction for wildlife and people, alike. These significant dollars are needed to counter the impacts that we have come to understand are the result of poorly regulated development within a watershed. In many ways this is a retrofit of infrastructure that should have been in place/required concurrent with such development, as "putting the genie back in the bottle" is always significantly more invasive and expensive, and likely never as successful. One example is the current mandate of converting outdated septic systems within certain watersheds – the cost estimates we've heard are staggering!

We would suggest that such considerations are the responsibility of those creating the potential impacts, rather than ignoring them with the expectation that someone else will deal with it at some point in the future when, of course, the costs will be far greater.

The City of Sebastian continues to grow, and within the last few years has approved its largest annexation ever of the Graves Brothers property on the southwest side of the City. In doing so, the City granted more than 10,000 housing units may be built on this property, in addition to commercial and institutional facilities. All of this is within the watershed of the South Prong of the St. Sebastian River.

The health of the St. Sebastian River also suffers from the impacts of increasing development within its watershed, and this annexation would provide nearly a doubling of the current population of the City. Several sections (WBIDs) of the River has been listed as "impaired" and included on the state's 303(d) "verified list" for a number of years, for low dissolved oxygen, and currently high iron levels.

One of the major impacts to the River and the Lagoon is stormwater runoff, which carries with it nutrients and pollutants that result in degraded water quality, and adds to the legacy



load of muck deposits in these waterbodies which are regularly disturbed, fluxing the nutrients, all of this resulting in harmful algal blooms (HAB) and in the worst case scenario, fish kills. In the case of the Indian River Lagoon, this has also resulted in significant degradation of seagrasses, the primary food source of the manatee, resulting in extraordinary mortality events within the last several years.

There are many efforts in Indian River, and especially Brevard County, attempting to address these issues, but one of the more effective ways would seem to be to stop the source(s) of the pollutants, stormwater being a major one.

Sections of the Indian River Lagoon are designated as an "Outstanding Florida Water." The Florida Department of Environmental Protection defines an OFW as: "An Outstanding Florida Water (OFW) is a water designated worthy of special protection because of its natural attributes. This special designation is applied to certain waters and is intended to protect existing good water quality."

Florida Statute 62-302.700 Special Protection, Outstanding Florida Waters, Outstanding National Resource Waters, designates the section of the Indian River Lagoon from Malabar to Ft. Pierce as an Outstanding Florida Water, as a result of this area being also designated as an "Aquatic Preserve," with the St. Sebastian River being the primary tributary to this section of the Lagoon. In addition, the Pelican Island National Wildlife Refuge is an overlapping OFW in the vicinity of/adjacent to Sebastian. Yet this statute specifically exempts the "Sebastian Creek," (one of its historical monikers), from OFW designation. Certainly this is a political delineation, which is of no consequence to wildlife and its required habitats.




