ALEXIS THOMAS - THE ENFORCER

Well, it's not as scary as it sounds! Alexis Thomas was hired by Indian River County to educate the public about, implement, and enforce the relatively recent fertilizer ordinance. That ordinance was enacted to help prevent yard fertilizers from leaching into our local waterways, and therefore help improve the health of the Indian River Lagoon.

The ordinance regarding fertilizer and landscape maintenance has been in effect for over a year, but many citizens are still unaware of what it really entails. This presentation breaks down the ordinance piece by piece and explains what the new law is and how it is to be followed. Also covered will be ordinance-friendly tips for taking care of your turf, and products available around the county that are in compliance with the ordinance.

Ms. Thomas' official title is Indian River County Stormwater Educator and Fertilizer Enforcement Officer; a diverse job that ranges from teaching kids about watershed pollution, to harvesting algae, to training landscapers on the ordinance. She grew up in Sebastian, graduating from Sebastian River High School before attending the University of South Florida, earning a Bachelor's degree in Environmental Science. Known in high school for her "tree hugger" ways, it is not surprising that she has returned to implement her environmental passion and knowledge to protect the home she grew to love.

Ms. Thomas' was also the recipient of the Friends' George Schum Award in 2008! We are happy to have played some small part in promoting her environmental interests and glad to have her back in the area putting those talents to work.

FLORIDA LAWMAKERS CONSIDERING USE OF AMENDMENT 1 FUNDS

There has been a lot of talk in the halls of the Legislature and the media about what conservation projects qualify for Amendment 1 funding. There are many hands reaching into the cookie jar for projects that lack a true conservation purpose.

The good news is that we've changed the debate. Lawmakers are asking questions of scientists and experts and listening to the informed opinions of conservationists and state agencies. At virtually every meeting relating to conservation and protecting our water resources, our legislators have shown that they are well aware of how strong the support for Amendment 1 is among voters.

The media also is paying close attention to what happens in the Legislature. They are on the look-out for any shenanigans lawmakers might pull with Amendment 1 funding. Nobody, it seems, wants another Lottery Amendment

Now, we need you to be ready. Any day now the Senate and House will be releasing their proposed Amendment 1 allocations. If their numbers don't align with ours, if they dedicate Amendment 1 dollars to sweetheart deals that benefit only a few, if they simply replace existing funding with Amendment 1 funds, we'll need you to contact your Senators and Representatives and give them a piece of your mind.

You can weigh in with your comments now on how Amendment 1 funds should be spent. Florida's Water and Land Legacy organization which organized efforts to get the amendment on last year's ballot, has a sample comment letter on their website, and addition talking points to consider. APRIL IS WATER CONSERVATION MONTH

The St. Johns River Water Management District has designated April as Water Conservation Month.

"Water conservation is at the core of the District's mission of protecting and ensuring the sustainability of Florida's water supplies," said John Miklos, chairman of the District's Governing Board. "Recognizing Water Conservation Month helps to encourage water users to take simple steps to conserve."

More than half of all residential water use is outdoors for lawn and landscape irrigation. Following districtwide lawn watering rules helps ensure the efficient use of water for landscape irrigation. The rules specify the days when residents and businesses may water.

Watering wisely year-round promotes healthier lawns and landscapes and can save thousands of gallons of water per month, as well as save homeowners money. INDIAN RIVER LAGOON SEAGRASS MAPPING

The St. Johns River Water Management District, South Florida Water Management District and Florida Department of Environmental Protection (DEP) are partnering to map seagrass in the Indian River Lagoon (IRL) this year.

Mapping IRL seagrass enables the agencies to identify areas of the estuary along Florida's east coast that may warrant special protection and potential problem areas that may warrant further investigation. Seagrass is an important indicator of the health of the lagoon, as well as a food source for manatees and sea turtles, and a nursery, refuge and foraging habitat for a variety of fish and other marine life. Mapping is performed every 2 to 3 years to provide an overall picture of seagrass in the lagoon.

"Mapping seagrass in the lagoon allows our scientists to track changes over time," said William Tredik, leader of the St. Johns District's Indian River Lagoon Protection Initiative.

From early spring through late fall 2011, two massive blooms of phytoplankton caused a loss of about 47,000 acres of seagrass throughout the lagoon system. In 2013 DEP adopted restoration plans for the IRL, known as basin management action plans or BMAPs. The BMAPs identify project zones based upon the distinct hydrology of the basin.

The 2013 mapping of IRL seagrass reflects some encouraging progress. The mapping revealed a 12 percent

gain in seagrass acreage compared to 2011. Median seagrass depth has increased in almost all of the project zones as well. Both of these are encouraging initial signs of recovery. Between the summers of 2013 and 2014, scientists also recorded moderate increases or no loss of seagrass at 52 out of 69 study sites. The results also indicate a general loss in shallow and deep seagrass edge.

"The mapping project reflects some improvements and will also help us identify other areas in need of additional restoration," said Tom Frick, Director of DEP's Division of Environmental Assessment and Restoration. "We are working toward our restoration targets, and we will continue to work alongside state and local partners to invest in the projects necessary to restoring this remarkable estuary."

STATE MANATEE COUNT A RECORD

Warm temperatures and clear, sunny days between some of the coldest weather of the year assisted Florida Fish and Wildlife Conservation Commission (FWC) biologists and partners in counting an all-time high number of manatees during this year's statewide aerial survey.

The FWC reported a preliminary count of 6,063 manatees statewide. This year's synoptic survey count exceeded the previous high count for 2010 by almost 1,000 animals.

"Manatees used warm-water sites and other winter habitat areas to cope with a strong cold front that recently moved through the region," said FWC biologist Holly Edwards. "In many of the regions surveyed, warm, sunny weather caused manatees to rest at the water's surface, which facilitated our efforts to count them in these areas. Calm waters and high visibility also contributed to the high count."

"We were very fortunate to have near-optimal conditions for our survey this year," said FWRI Director Gil McRae. "The high count this year is especially encouraging, given the large-scale mortality events that resulted in over 800 deaths in 2013."
