## **AN UPDATE ON CONSERVATION AND RECREATION AT THE ST. SEBASTIAN RIVER PRESERVE STATE PARK**

Samantha McGee, Park Biologist at the St. Sebastian River Preserve State Park will be the guest speaker at our September General Meeting. Sam will give a presentation about changes at the Preserve and an overview of their continuing efforts of habitat restoration, prescribed burns, conservation of scrub jays and red-cockaded woodpeckers, and recreational opportunities.

The meeting is Tuesday, September 24, 7:30 PM at the North Indian River County Library, 1001 Sebastian Blvd. in Sebastian. The meeting is free and all are welcome to attend.

## **FLORIDA WATER & LAND LEGACY CAMPAIGN**

As we've reported to our members by email, the Florida Water & Land Legacy Campaign now has a copy of the constitutional amendment petition available on their website. Several hundred thousand more signed petitions will be required in the next few months, in order to get the amendment on the 2014 ballot. ## WHAT'S HOT

As you may know, there was a major improvement made to Indian River County's fertilizer ordinance this summer! The IR County Commission approved adding the recommendations of several people and organizations, strengthening the ordinance to help prevent lawn fertilizers from being leached into our local waterways during the rainy season. Thanks to all who spoke up and made your voices heard, to impress upon the commission the concern that most everyone shares for the lagoon.

Other local communities have also revisited their ordinances recently, some taking similar steps to help minimize fertilizer runoff. The City of Sebastian this month though voted 4 to 1 to reject any improvement to their ordinance, which is the state's "model" fertilizer ordinance. Not that strengthening the model ordinance is the silver bullet to correcting the crisis in the lagoon, but it would seem to be a simple and logical step, that many coastal communities around the state have undertaken, and appears to be having a positive effect.

The DEP's model fertilizer ordinance is not the "ideal" for minimizing fertilizer runoff. Rather it was the best the state was able to negotiate with stakeholders in this issue – the result of the political "sausage-making" – a compromise or lowest common denominator. But in the end, ultimately it is up to us, the public, to do what we can to help our severely ailing lagoon. And this month starts the busy season with lots of events and activities already on the calendar! On Sep. 21st is the International Coastal Cleanup, sponsored by the Ocean Conservancy. Local host for the cleanup in Indian River County is Keep Indian River Beautiful (772-226-7738) and Keep Brevard Beautiful in Brevard County (321-631-0501). On Sep. 28th there are multiple events around the lagoon to help educate folks about our lagoon and estuaries (National Estuaries Day), show your support for efforts to restore the lagoon (Hands Across the Lagoon), and participate in hands-on volunteering to help improve our public lands (National Public Lands Day). We've listed details of many of the events on our website, so be sure and check out the "Meeting Info/Events" page. And be sure to get out to show your support, and learn more about our lagoon and how you can help!

Harbor Branch Oceanographic Institute (HBOI) and the Ocean Research and Conservation Association (ORCA), both of Ft. Pierce, are working on research in the lagoon to help with the understanding of what has caused the sudden decline in lagoon habitat and water quality. HBOI is conducting research work with the assistance of some graduate students. One is working in and around our area and is looking for volunteers to help with water testing. Please contact us if you are interested and we can put you in touch with the right person.

Dr. Brian LaPointe of Harbor Branch gave a presentation at one of our meetings last year on his work in the lagoon. His preliminary results show that nutrients leaching from septic systems may be significantly contributing to water quality issues in the lagoon. So we are glad to see the City of Sebastian considering ways to provide county sewer service to waterfront locations. There is no quick, short-term solution and costs could be substantial. The federal government will likely mandate such improvements, but significant grant funding may be available.

We are also working on developing some walking tours in and around the St. Sebastian River area for the coming season. ## FLORIDA SURPLUS CONSERVATION LANDS ASSESSMENT

The Florida Department of Environmental Protection has undertaken an assessment of state owned conservation lands, for the purpose of determining if any properties can be considered “surplus” and sold. This assessment was mandated by this year’s Florida Legislature as a condition for approving funding for the Florida Forever program – a national leading program for the acquisition of lands for the purpose of conservation.

The Acquisition and Restoration Council, the state’s committee reviewing the properties being considered, met on September 13<sup>th</sup> to review the listed properties, and initial public comments were solicited. There are two islands in the South Prong of the St. Sebastian River that are currently on the list and we submitted comments regarding these islands. We received an immediate response from the DEP, which is too lengthy to include here in our newsletter, but you will find the full text on our website, under “Local News”, dated September 13, 2013, on the “News and Information” page of our website.

Additional public meetings will be scheduled in the next few months to present information and receive public input; one of which will be scheduled in the Melbourne area.
